**TECHNICAL REHEARSAL WEEK:** May 30<sup>th</sup>-June 5<sup>th</sup>. We will be holding dress rehearsals within the studio. You will arrive during your regular class time and they will rotate rehearsing in studio 2.

**BALLET PRODUCTION REHEARSAL:** June 5<sup>th</sup>, 5:30-9:30pm @ Lake Travis HS PAC. Since this production involves overlapping classes, we have found the need for an additional rehearsal on the stage prior to recital.

**PICTURE WEEK:** May 16<sup>th</sup>-22<sup>nd</sup>, in the studio during your class time.

**BALLET PRODUCTION:** There will be a separate meeting and information handout for those classes who are involved in the Ballet Production.
